INFLUENZA CONSENT & ADMINISTRATION FORM

Form fields for Patient Name, Sex, Date of Birth, Address, City, State, Zip, Telephone, and Primary Care Provider (PCP).

Note to all individuals requesting the influenza vaccine can be safely administered. Please complete the following questions to evaluate any contraindications to the influenza vaccine.

- 1. Do you have any serious, life-threatening allergies?
2. If yes, describe the allergies.
3. Do you have a fever or active illness?
4. Do you have a past history of Guillain-Barre Syndrome?
5. Do you have a history of asthma or wheezing? (for intranasal administration only)

As with any medication, there are risks and possible side effects/reactions. Side effects/reactions of influenza vaccine are generally mild, usually occur soon after vaccination and last for 1-2 days. In rare cases, side effects/reactions of influenza vaccine may include anaphylaxis and even death. If you think you are having a severe reaction or other emergency, STOP, SEEK HELP IMMEDIATELY.

I have received and reviewed the Influenza Vaccine Information Statement (ISVIS) (2019) and have had the opportunity to ask questions. I have been advised to remain under observation for at least 15 minutes following vaccination. I understand the benefits and risks of the influenza vaccine as described. I hereby agree to release and hold McLaren Medical Group, its employees, agents and representatives, harmless from further responsibility with regard to my receiving the vaccine. I request the influenza vaccine to be given to me or to the person named for whom I am authorized to sign.
