If Medicare does pay, you will refund any payments I made to you, less co-pays or deductibles.

**OPTION 3.** I don't want the D. HEPATITIS A-B listed above. I understand with this choice I am not responsible for payment, and I cannot appeal to see if Medicare would pay.
