I understand that my treatment at McLaren Flint may involve the transfusion of blood or blood cell products. The blood or blood product used is obtained in conformity with policies of the American Red Cross to ensure quality and safety of the product. However, transfusion does carry some risks. Non-serious reactions could include head-ache, chills, fever or skin irritation or infection at site of transfusion. Serious reactions are very unlikely but include transmissible diseases such as viral hepatitis, or other blood borne diseases. Finally, despite careful testing and handling, there is a slight possibility of transfusion reaction.

Transfusion will only be used if my doctor believes it is in my best interest. I have been provided with information regarding alternatives to the administration of blood products. My decision (below) to consent to a transfusion also indicates my acceptance of the risks associated with transfusion, with recognition of those risks.
