APPLICATION REQUIREMENTS

- Be a graduate of an ACPE accredited school or college of pharmacy or have a Foreign Pharmacy Graduate Equivalency Committee (FPGEC) certificate from the National Association of Boards of Pharmacy.
- Submit your application, including CV, letter of intent, academic transcripts, and three letters reference to PhORCAS by January 2.
- Be eligible for Michigan Licensure.



OUR PHARMACY RESIDENCY

McLaren Oakland is a 328-bed medical center that provides primary and specialty healthcare services to the greater Pontiac and Oakland County community.
