NOTICE OF PRIVACY PRACTICES

This notice describes how health information about you may be used and disclosed and how you can get access to the information. Please review it carefully.

WHY WE'LL PROVIDE THIS INFORMATION TO YOU (BASED ON THIS NOTICE)

McLaren Health Care ("McLaren") provides health care to our patients in partnership with physicians, health care providers, and other professionals and organizations in an integrated health care environment. Reasonable efforts are made to ensure that you are given notice of the information sharing practices. The practices in this Notice will be followed if:

- You have given permission for participation in an integrated health care environment with all physicians, other health professionals, and other health care professionals.
- We anticipate and anticipate an integration across our health care including hospital emergency department, urgent care centers, mobile units, skilled nursing, ambulatory surgical centers, urgent care centers, home health, hospice, cancer centers and other health care services. These services may be provided at or contracted for services at participating services.
- Our employees, staff and students, including volunteer staff and affiliates.
