McLaren Physician Partners (MPP) is a state-wide clinically integrated network (CIN) with 15 acute care hospitals and over 2,600 Primary Care and Specialty providers. McLaren is a leader in Population Health, and we are dedicated to engaging our physicians in adopting clinical guidelines to reduce the variability of the care provided and commit to goals of top decile performance in Quality, Cost, Patient Safety, and Patient Experience.

MPP's focus is on providing resources to physician offices which provide value to support Patient-Centered Medical Homes, contracting, care coordination services to manage patients with chronic medical conditions and optimize financial performance under risk-based contracts.

MPP providers are eligible to join the McLaren High Performance Network (MHPN) entity, our ACO, which has a downside risk MSSP contract with CMS.

Membership Benefits:

- **Medicare, Medicaid and Commercial Payors (Employers) are requiring (Value Based) Upside and Downside Gain sharing contracts where providers are at risk for the cost and quality of care provided to patients.**
- Current Payor contracts professional fee schedules are flat, Value Based contracts provide a new revenue source while meeting employer and CMS demands to manage the cost of care.
- **Less enrollment burden for PCP and Specialists to participate in payer contracts.**
- Patients and referrals directed towards higher performing specialist members in the MPP High Performance Network.
- **Access to new Gain Sharing Risk contracts**
 - **Significant revenue opportunity for providers**
 - **Medicare Advantage Shared Savings such as Humana, Blue Cross, and Aetna**
 - **MSSP ACO Track E, upside & downside risk**
- Clinical Integration (CI)
 - McLaren is accountable for the cost and quality of care for our attributed populations.
 - Physicians are required to participate in:
 - **MPP Care Coordination programs including managing patient transitions among care settings to home**
 - Utilization of evidence-based guidelines to deliver the most effective care in the most appropriate setting
 - Gain sharing contracts fund CI pool for distribution to Primary Care and Specialists physicians.
 - 2022 median CI payments of \$50,000 for PCPs and \$6,000 for Specialists
 - **Over the last 5 years, MPP has distributed over \$47 million through our CI Program.**
 - Our top physician received \$408,000 during this period.

 - **Over \$87M in Savings first five years**
- **2022 MIPS Performance:**
 - Final Score of 98.53 out of 100:
 - CMS considers this in the exceptional performance category, all McLaren ACO members will receive an additional reimbursement of 7.36% on all professional claims for services rendered in 2024..

- Web-Based Population Health Performance Management System, Persivia:
 - Real-time Population Health Registry, HEDIS Quality Metric Engine.
 - Registry imports EMR and claims data to provide a clinical view of patient and identifies gaps in care or clinical opportunities.
 - **Care Coordination Tools to support clinical patient care in the post-acute setting and to allow the practice to bill for care coordination services (CCM/PDCM).**
 - Admission, Discharge and Transfer (ADT) feeds of patient transitions from hospital or SNF to home-based care.
 - Electronic submission of quality metrics to health plans and MiHIN.
 - CI and Quality Metrics Scorecards & Reporting (Peer to Peer benchmarking).
