Safety, Visits and Testing

Scheduling Appointments

- Ask patient if they would prefer a telehealth visit (reference the Phone Scheduling Scripting for making an appointment)
- •If patient is known COVID positive, it is recommended they don't come into the clinic until >5 days from symptom onset/ positive test; unless provider decides otherwise (patient/visitor must wear mask when in clinics)

Waiting Rooms/Check-In Areas

- Cover your Cough sign
- Tissues and trash can
- Hand sanitizer
- Masks for those with respiratory symptoms
- Signage for separation of sick patients when feasible

Cleaning and Disinfection - Waiting Rooms

- •Clean and disinfect the waiting room/check-in areas when visibly soiled **and** at regular intervals (e.g., mid-day/end of day) with a focus on high-touch surfaces
- Clean pens before patient use

Patient Placement/Exam Rooms

- •Rooms used for respiratory specimen collection, nebulizers or MDIs should have a HEPA room filter running during clinic hours when possible
- Reminder to purchase replacement filters and change them per manufacturer's instructions
- Contact the team that evaluates your electrical equipment. This
 machine will need to be reviewed and tagged

Patient Equipment

•Only use disposable mouth pieces for spacers, nebulizers and single patient-use MDIs. Discard after one patient use.
